6. District Councillor

- ML told the meeting that the Local Plan had been published and there had been a lot of negative responses, especially from Beaconsfield. The fact that parts of the Green Belt will be used as there is a 500 short fall of houses for that area.
- When the consultation is due, Councils will be informed.
- ML also said that by the end of May, the Unitary will be passed by Government officially.
