We would be concerned for the structural integrity of the building which may be impacted by lowering the internal ground height and potential water ingress.
<a href="#">PL/22/0569/FA</a> <b>Waterfield</b> <b>Hedgerley</b> <b>Hill</b> Hedgerley SL2 3RJ	Two storey rear and single storey extensions to both sides/rear. Demolition of existing extension and covered carport.	HPC does not have any objection to this proposal, providing the front elevation (view from the road) is in keeping with that row of houses on Hedgerley Hill and that the increase in built environment is permitted within the Green Belt.
