Part two, part single storey rear extensions additional windows to side elevation.

This proposed development appears to be a large-scale extension and Hedgerley PC is concerned whether the scale is within appropriate limits, especially with the close proximity to the neighbouring property, and request that this application be called in for consideration by the Planning committee.

Court Farm, Village Lane, Hedgerley, SL2 3UY

Listed building consent for roof covering replacement to main house and summerhouse with roof and parapet repairs.

Hedgerley PC does not have any objection to this proposal, providing the heritage elements of this Grade 2 listed building are preserved.

**Re. Court Farm**

There seems to be building works in progress at Court Farm, and although several planning applications have been made following a recent change of ownership, only one has been granted to date. There appears to be scaffolding erected, as if for roof repairs, and also rebuilding of the side wall, which looks like widening of the side entrance. Also several complaints from residents regarding noise out of normal working hours. Planning enforcement to be contacted on this.
