1. Elections

Clerk told the meeting that she had spoken with Wayne Fabian, our local LAT (Local Area Technician) regarding the damage to the verge outside Duneen, caused by the residents driving their cars across the verge instead of their driveway entrance. Wayne said that they were writing to the owners, telling them that they were not allowed to drive across the verge. He suggested the only way this would be possible was to go through the legal channels of applying for permission to have a dropped kerb and new access. In the meantime, Councillors are asking Wayne to make the damaged area made good. Clerk to arrange.
