### Community Submissions

- Defibrillator - waiting for confirmation of start date.
- MVAS  
Device has been checked over and NC confirmed it was the original HPC MVAS. Will be put in place at the Top Farm site until next meeting.  
MER pointed out that the ground anchor for the Hedgerley Hill site was loose and needs re-setting.
- Had complaints about the 'Narrows' regarding the apparent excessive speed. Request that the speed should be 20 mph. Clerk had informed the resident that unless there had been several incidents which were attended by Police/ambulance, there was nothing to be done. TB asked the Clerk to see if Highways can install a 30mph sign at the far end of the Narrows as there is no indication of speed limit from that end.
- Complaints from Coppice Way residents regarding flooding in the road. Due to the very heavy and continued rainfall at that time, there was considerable flooding across the whole of S.Bucks. Situation in Coppice Way and Hedgerley in general will be monitored
