7. Planning

To note report - there were no new applications this time. DB told the meeting that the Reservoir application had again been refused. This time on the grounds of Green Belt.
8. Play area

- The replacement swings had been installed. Martin Marfe of Sutcliffe Play and his engineer were calling to visit a project in Slough and stopped off to put up the swings for us, free of charge. This was much appreciated.

9. Property

- Quad bikes in Kemsley Wood In order to prevent further activity from people riding quad bikes in the woods, one bollard has been installed at the entrance to the Robert Road alley, and another will be in place at the far end of Kemsley Wood at the Parish Lane exit.
- It has come to light that evidence has been discovered of ash die back in Kiln Wood. Further investigation to be undertaken.
- Kemsley Wood - holly. In order to prevent the holly becoming a nuisance again, the Forestry Commission Woodland Officer has recommended that in order to fulfil the grant commitments, there will need to be deeper mulching.

10. Slade Farm

There had been concerns that concrete and tarmac lorries had been seen coming through the village and also leaving the sight towards the Hedgerley direction. We had been in touch with Andy Clark of Ingreborg Ltd. who was positive that no vehicles would have been using Hedgerley as a short cut and also provided a plan showing the difficulty they would have in turning right out of the site as the exit was made to only curve to the left out of the site. Clerk to put notices and FB asking that anyone seeing lorries going through should take note of the licence plate and the company name.
