## **Community Submissions**

Maddie and Sarah, Committee members of the Memorial Hall have asked for help/suggestions for a way forward for the future of the Memorial Hall. They say in two years, if things don't improve financially, it is more than likely that it will not be a viable option to continue.

They have thought of capital investment – solar panels, oil, anything to get the costs down.

It was 2k p.a. and has now increased to £6k p.a. They are looking for advice on grants.

Since Covid, the use of the hall has decreased and have lost considerable revenue. Birthday parties are now very rare, three or four gym sessions have gone.

They have been approached by a Montessori school, which would be 9.00 – 3.30 daily. This would mean that the people who do organise a daily event would lose out, and that would not be a welcome result.

Given the above and due to the part retrospective nature of the application, HPC would like to call this application into the into the Planning Committee for consideration.
