4. Bucks Council

Elected Unitary Councillors for Gerrards Cross, West Beaconsfield and Hedgerley are Thomas Broom, Andrew Wood and Michael Bracken. There are 150 Councillors for Bucks Council.

5. Clerk's information items

- <u>Derek Baker</u> Councillors were sorry to see Derek retire as a Councillor. His knowledge regarding Planning matters will be sorely missed and we wish him well for the future.
- <u>Dirk Easchus</u> Dirk has now moved away from the village, even though only a short time as Councillor, his willingness to engage with the various village problems was much appreciated and will be missed by many.
- <u>Defibrillator</u> At the last communication with BT, it was confirmed that they would not be able to re-install the electric supply. Councillors have agreed that another quote be requested from the private company that we previously approached.
- Hanging Wood Clerk had been contacted by residents regarding the farmer (John Russell) putting up a fence and gate to the 'unofficial' pathway through Hanging Wood. It would appear that this path has been used for over twenty years, thus making it permissible to use. Clerk had provided all the information and maps included the form for people to fill in and send to BC. This is not an HPC matter, but the BC Rights of Way officer should be investigating.
- Newt Conservation partnership we have been asked for permission to carry out a survey of the pond to help with research into pond biodiversity across the region. Councillors were happy for them to carry on.
- <u>Pond clearing</u> Clerk was informed that BC does not maintain the pond, only the thin line of verge along the roadside there. Clerk to find appropriate methods of emptying.
