Minutes of Parish Council Meeting held on 9<sup>th</sup> November, 2015 In the Youth Club Hut, Hedgerley

# Chairman indicated emergency exits Apologies for absence – none

## Pond posts – update

Regarding the invoice from First Class Gardens, Councillors agreed to defer pond posts payment until the work had been inspected and verified as complete per the quotation.

#### Bench or Tree in memorial to late Ted Evans

It was agreed to have a bench in memorial to the late Ted Evans. This would be similar to the benches on the Green; being a Timberpol slatted recycled material bench. NC to suggest the wording for the plaque and Clerk to confirm costing.

#### 9. Slade Farm – Update

The public meeting is due to take place on Saturday 14<sup>th</sup> November. 1<sup>st</sup> December is the Development Control meeting. Public are allowed to speak, but only by previous request. Due to the large number of objections (over 180) received by BCC the matter likely will not be considered before the February meeting. Accom had sent a very detailed report for the Council to form the basis of the Council's objection - it was agreed to send a suitably edited version of this report to BCC.

There were two speakers – one from Prevention Matters on early intervention services in Community support; helping people to stay independent. The theme of the second was by Active Bucks. Clerk told the BCC representative that as Hedgerley already had pilates and bowls organised independently, and that Community led walks would be preferable. Clerk will keep Councillors informed of further developments on this.

#### Democratic period

It was asked if there was any information on the traffic strips which appeared at the end of Hedgerley Lane. Clerk had made enquiries, both with Beaconsfield Town Council and TfB, but no one knew about it.

Tom Webb told the meeting that the Rememberance Service had been very well attended and the Scouts had marched through the village. He suggested that HPC remind people in advance that this would be happening next year.

Council was told that the War Graves Commission had approved the erecting of a headstone for Christopher Bowden, who was medically discharged after contracting tuberculosis in WW1 and returned to Hedgerley where he died in December 1916... headstone to be erected in St. Mary's churchyard, where he is buried.
