- Information board for the Community Orchard Clerk had been in touch with the company who provided the previous environmental boards in the village. They need to know what size is required and the content in order to give costings. Clerk will contact Maddy Bushnell on this.

  meeting that the Rugby club were still having to walk the pitch in order to dispose of
  dog faeces which were being left on the Green, even though there is a dog bin located
  at each corner of the Green. It was suggested that CCTV be used to find out the
  culprits.
- Also the continued parking on the edge of the Green along Jones Way. Councillors to consider action on this.
