<u>Flooding</u>

Litter

I have informed the SBDC Portfolio holder for waste about litter on Hedgerley Lane. The other litter on Pyebush and MSA roundabouts are County so I have contacted the appropriate officer at BCC. The roads that are faster than 30mph speed limit are County because of needing road traffic restrictions to safeguard the workmen.
